Golf Outing Requirements:

20 players are required to be considered for outing prices, and obtain advance booking. Golf course will not shotgun start for groups of 28 players and under. Tee times will be utilized.

32-76 players. Golf course will utilize a staggered shotgun start. *Will remain open to the public.*

80+ players. Golf course will be closed for golf outing participants only and a shotgun start will be utilized.

Monday-Thursday **\$24.00** Friday/Saturday/Sunday **\$28.00**

****Golf outings held before Memorial Day weekend and after Labor Day weekend may be eligible for further discounts.**

****Local charity based organizational golf outings may be eligible for further discounts.**

****Outings resulting in numbers greater than 80 are eligible for an additional discount per golfer.**

Outing Rules:

1. A number of golfers must be received seven days in advance of the golf outing date.
2. Payment in full for the outing must be made on the day of the event. Please bring separate checks for both golf and food. Full credit for your deposit will be applied to Golf Fees. Approval from Elks 797 Golf Club management is required for any delayed payment.
3. All golf outings will be played rain or shine, unless the course is closed. The Elks 797 Golf Club management will determine if the golf course is playable. If the course does close rain checks will be distributed.

4. Advance golf outing bookings are available for groups of 32+ players. All that is required to reserve your outing is a signed contract.

To help your outing run smoothly, we encourage the event sponsor to collect any fees from participants prior to the event. All outing fees are due the day of the event and their collection is the sole responsibility of the event sponsor. If you need to cancel your outing, please contact Elks 797 Golf Club as soon as possible. We must receive your confirmation of the number of participants 7 or more days in advance to properly plan for the size of the outing.

5. Cancellations received 14 days or more prior to your event will incur no cancellation fee. Cancellations received less than 14 but more than 7 days prior to the event will be charged **\$150** fee. Cancellations received less than 7 days prior to the event will be responsible for the **entire amount** of the contract.
