## **Elks 797 Season Pass Holder Code of Conduct Agreement**

### **Rules:**

1. I will always respect the employees both in the Pro Shop and on the Grounds Crew.
  - a. Any issue with staff or operations will be privately taken to management i.e. Pro Shop Manager or Course Superintendent.
    - i. Any non resolved issue will be taken to the Golf Board President.
2. I will do my best to maintain course conditions:
  - a. Fixing Ball Marks on the greens
  - b. Sanding Divots on par 3s
  - c. Fixing divots in the fairways
  - d. Raking Traps when finished
  - e. Making sure my trash gets into the proper receptacle
3. As a member I acknowledge preferential tee times on weekends and holidays but forfeit all rights as a walk on.
  - a. Coming to the Pro Shop on a busy morning without a tee time will not guarantee you the ability to access the course.
  - b. When in doubt, make a tee time.
4. ***I will always check in with the Pro Shop before heading on to the course.***
5. I will be a leader in cart etiquette standards for the general public.
  - a. Obeying Cart Rules
  - b. Returning carts in an organized fashion
  - c. Returning keys to the pro shop when finished.
6. I will not speak in a negative tone of the club around non members in a way that can harm the club's reputation. (see rule 1a)

### **Disciplinary:**

1. Any employee has the right to report any violations of the Code of Conduct to the General Manager or Golf Course Superintendent.
  - a. Management will make all decisions on the proper course of action as to how to handle any negligence.
2. Most issues will be dealt with on a three strike policy:
  - a. Verbal warning
  - b. Written warning
  - c. Corrective Action Required (Including possibility of suspension of golfing rights)
3. There is a 0 level of tolerance for disrespect of an employee, the course, or equipment (carts included).
  - a. Any violations can result in an immediate suspension and bypass the written warnings.
4. *Any appeal of a punishment can be brought before the Golf Board at the beginning of the biweekly meetings.*
